- d. President leads HOPS. Vice President leads in place of President as needed. Secretary makes newsletter and records minutes. Treasurer collects, submits monthly to the newsletter accountings and expends funds. Trustee – operates the annual bus trip.

Article V – Officers Proposed

- a. The officers and hierarchy of the club shall be President, Vice President, Secretary, Treasurer and one Trustee. Elections will be held yearly for all officers. President must have held another office previously.
- b. The officers are the executive committee and shall provide leadership and guidance to the membership at large.
- c. Call for nominations two months prior to the annual meeting. Vote January, take office February.
- d. President leads HOPS. Vice President leads in place of President as needed. Secretary makes newsletter and records minutes. Treasurer collects, submits monthly to the newsletter accountings and expends funds. Trustee – operates the annual bus trip.
- e. In the event that a monthly meeting is held and an officer is not in attendance, HOPS business may be tabled until the next meeting. Or can be added to Article VII
- f. An officer may resign with or without cause. Failure of attend three consecutive HOPS business meetings shall operate as a tender of resignation.
- g. The succession of officers will be hierarchy of officers in descending order.
